**Thompsonville Sidewalk Proposal:** Thompsonville Board President, Geno, provides information that re: approx \$11K in funds they have collected over the past decade or so that they have recently become aware they were supposed to spend on non-motorized pathways. The Thompsonville Board has agreed they would like to see the money used for sidewalk replacement, and are going to the two townships within the Village to seek additional funding to help make this project meaningful by gaining as much financial support as possible to maximize the footage of sidewalk able to be installed. The Village proposes to spend 50% of their funds on sidewalk replacement in each township. Discussion, mention of possible grants to help fund as well; no action.
