Recycling

Dates and locations for residential 2019 household hazardous waste, electronics and scrap tire collections were not finalized in time for this newsletter. However, tentative dates are June 15 and August 17, plus July 13 for tires only. Township and county recycling websites will be updated when finalized.

Appointments are required for these collections. Call 231-882-0554 or email Jesse Zylstra, Benzie County Recycling/Solid Waste Dept. at benzieco.net for appointments. There may be a small charge per pound for TVs and monitors due to Michigan's e-waste policy. Residents can use any recycling bin in the county for #1-7 plastics plus the hard "clamshell" type, tin aluminum, clear/color glass and jars, paper, junk mail, flattened cardboard, juice boxes, milk cartons and Styrofoam. Bins in Thompsonville are at the Village DPW on CR669/Thompsonville Hwy. near the four-way stop.
